Office/Reservations: Thursday to Monday, 8am to 5pm (closed Tuesday and Wednesday)  
Campground: Open year round  
Park and Picnic Area: Open year round  
Lake/Waterfront: Seasonal: Memorial Day to Labor Day

Smith Lake Recreation Area is located off the installation on Smith Lake Rd. Ft. Bragg, NC. The closest Access Control Point (Honeycutt Gate) onto Ft. Bragg is approx. 5 miles.

**Driving Directions:** I-95, Exit 58 onto I-295 Bypass, take exit 25B, follow signs

### Nearest Major Cities:

Fayetteville, NC/Spring Lake NC, 5-12 miles to the nearest shopping and/or food establishments

### Reservation Policy:

#### Eligibility:

DOD ID card holders and guests. Military ID card holder must be present at check in. The campground is not open to the public.

#### Length of Stay:

IAW AR 215-1, Homesteading is strictly prohibited. Extended stay is limited and based on availability.

Up to 60 days (May–Sep), Up to 90 days (Oct–Apr)

Must leave campground for a min of 10 days for new reservation

2 week maximum stay on pull-through RV sites

#### Reservations:

Accepted 90 days in advance.

##### **For reservations up to 30 days:**

A one night's rental fee per site is due at time of reservation and balance is due at check-in or optionally, weekly advance payments must be made for reservations 7+ days

##### **For reservations 30+ days:**

One week's fee is due at time of reservation and balance is due at check-in or optionally, weekly advance payments must be made.

**Method of Payment:** Cash, Credit Card (Visa/MC/Discover), Check (no 3<sup>rd</sup> part checks are accepted).

**Cancelation Policy:** Full refund with 7 calendar days' notice otherwise, one day rental fee will be collected.

**General Rules and Restrictions:**

- Check-in 1500hrs, Check-out 1200/Noon, Quiet Hours 2300pm to 0600am. A half day rental fee applies for early check in.
- Firearms/Weapons, Drugs, Fireworks and Off-Roading is prohibited
- Smoking and Pets are NOT allowed when renting a cabin
- Pets must be kept on the leash (Breed restrictions IAW Ft. Bragg policy)
- Additional shelter structures or tents may not be put up. Remain in your designated sites.
- Washing vehicles or RVs is strictly prohibited
- Open fires of any kind at the sites are strictly prohibited due to the close proximity of the wood line. Please use the fire rings in the designated communal areas near both bath houses.

**Amenities:**

- Bath houses with individual bath rooms
- Sewage dump station, complimentary for registered campground guests
- Coin operated washers and dryers
- Fishing on the north side of the lake; Ft. Bragg and NC fishing permit required, no motorized watercraft
- Mountain bike and hiking trails; Bike rentals available
- Park and picnic areas with ADA playgrounds, volleyball and basketball courts (fees may apply)
- Seasonal lake front operation: Swimming, Wakeboard Cable System, paddle boat/canoe rental (fees apply)

**Fees:**

**Primitive Tent Camping** (No electric/water hook up) ..... **\$12.00 per tent**

- Up to 6 guests per tent/1 vehicle
- Communal picnic and fire ring area (campfires not allowed on site)

**RV Sites, 30/50 amp, concrete pads and picnic tables on most sites:**

**Partial Service (water/electric)** ..... **\$18.00**

**Full Service back-in (water, sewer, electric)**..... **\$23.00**

**Full Service pull-through (water, sewer, electric)** ..... **\$25.00**

- Up to 6 guests/2 vehicles
- Discount for America the Beautiful card holders, \$2.00 per night

**Small, primitive Log Cabins** ..... **\$55.00**

- Max. occupancy 4, 2 vehicles
- 2 rooms w/double bed and bunk beds (rated for kids only), table & 4 chairs, AC/Heat, microwave and fridge
- No running water (bath houses in the immediate area)
- Must bring own sheets, blankets, pillows & towels
- No pets allowed (\$100 penalty for non-compliance and pet must be removed immediately)
- No smoking inside cabins

**Large Log Cabins, min. 2-night stay** ..... **\$135.00 per night**

- Max. occupancy 8, 4 vehicles
- Living Room, Loft, 2 Bedrooms, Dining Area (table w/4 chairs), Kitchenette w/dishes, Bathroom, AC/Heat
- Must bring own sheets, blankets, pillows & towels
- Outdoor covered grill and picnic table
- No pets allowed (\$100 penalty for non-compliance and pet must be removed immediately)
- No smoking inside cabins
