



## Finding A School

### Enrolling In Schools While In Temporary Housing

#### Information

#### Residing in Temporary Housing Off Post

- If you are residing in temporary housing **Off Post**, and you are able to obtain a 90-day letter from housing (stating that you will be in government quarters within 90 school days), you are eligible to register your children in Fort Bragg Schools, K-8th grade. If you have a high school student, your child will attend EE Smith High School (if you are living on Fort Bragg) or Overhills High School (if you are living in Linden Oaks)
- If you are residing in temporary housing **Off Post**, and you are **unable** to obtain a 90-day letter from housing, you are **INELIGIBLE** for Fort Bragg Schools.
  - You will enroll your child in the school district in which you are temporarily housed.
  - Locate your school in Cumberland County. To do this, visit the [Cumberland County Schools](#) website.
  - Locate your school in Harnett County: Call +1 (910) 893-8151
  - Locate your school in Hoke County: Contact Hoke County School Transportation office at +1 (910) 875-9271 or +1 (910) 875-3585.
  - Locate your school in Moore County: Contact Moore County Schools and request for Transportation office at +1 (910) 947-2976.
  - Locate your school in Lee County: Contact Lee /county Schools and request for the Transportation office at +1 (919) 774-6226.

#### Residing in Temporary Housing On Post

- If you are residing in temporary housing **On Post**, and you are able to obtain a 90-day letter from housing (stating that you will be government quarters within 90 school days), you are eligible to register your children in Fort Bragg Schools, K-8th grade. If you have a high school student, your child will attend EE Smith High School (if you are living on Fort Bragg) or Overhills High School (if you are living in Linden Oaks)
- If you are residing in temporary housing **On Post**, and you are **unable** to obtain a 90-day letter from housing or you plan to rent/purchase a residence off post, you are **INELIGIBLE** for Fort Bragg Schools. You must enroll your children in the following schools:
  - **Elementary School:** WT Brown Elementary School (2522 Andrews Church Road, Spring Lake, NC 28390 | +1 (910) 497-1258. Transportation is not provided.

- **Middle School:** Spring Lake Middle School (612 Spring Avenue, Spring Lake, NC 28390 | +1 (910) 497-1175). Transportation is not provided.
- **High School:** EE Smith High School (1800 Seabrook Road, Fayetteville, NC 28301 | +1 (910)483-0153). Transportation is provided from several bus stops on Fort Bragg, please contact Cumberland County School Transportation for the nearest bus stop: 910-678-2359)
- Cumberland County Schools will require an approved Emergency Housing form to enroll in school. This form is available either through Corvias On Post Housing, Fort Bragg Schools, or the School Liaison Officer.
