FINANCIAL DISCLOSURE: Patrons who do not wish to disclose financial information will be placed in category 9

MULTIPLE CHILD REDUCTION (MCR): A 15% MCR is offered to the 2nd and subsequent children in all regularly scheduled programs. Full fee is charged for the child in the most expensive care option, e.g., Full Day CDC vs SAC care. 15% MCR is offered to 2nd and subsequent children in Youth Sports programs occurring during the same season.

LATE PICK-UP FEES: Family fee \$1.00 per minute for the first 15 minutes; \$15.00 maximum, then \$5.00 per child for next 45 minutes. If Family has children at different sites, late pick-up fees are assessed per site. Fee is payable before the child is readmitted to care.

PAYMENTS: Childcare services are billed on the 1st and 15th of the month. Payments are due by the 5th business day of the month following the bill. A late payment fee of \$10.00 per child will be assessed on the 6th business day of each missed payment cycle. Full payment (to include late payment fees) must be received by the last working day of the month or services will be suspended until full payment is received. Families risk losing their child care space on the last working day of the month, when full fee payment is not received.
