



## **Military Family Month - Family Scavenger Hunt Rules November 2017**

### **GENERAL INFORMATION**

All participants must be registered by close of business THURSDAY, NOVEMBER 9. Registration form must list all family members participating (names, ages). The Release of Liability form must also be completed for each Family/participant.

Hunt officially begins November 1 and ends at **NOON** November 20. The official hunt list will be posted by 10 a.m. on November 1 at [www.bragg.armymwr.com](http://www.bragg.armymwr.com)

Small items should be placed in zip-lock type bags and labeled to ensure they are not lost and can be accounted for. All items must be exactly as described on the list (Xerox copies or any other substitutions are only accepted when specifically noted on the hunt list). When in doubt, please ask!

All items must be secured in brown grocery bags or boxes (responsibility of participant) and clearly labeled with participant name and phone number prior to being dropped off.

Cameras and film developing/printing are the responsibility of the participant.

The team with the most POINTS (not necessarily the most items) wins! In the event of a tie, two (2) items on the list has been pre-identified as the tie-breaker(s) and will be sealed in an envelope. The team having the item/points will be the winner. If an additional tie remains, the team with the most items AND bonus items will be the winner.

**NOTIFICATION** - All participants will be notified of results by email by close of business Wednesday, November 22.

**PRIZES** – The winning team will win a 3-minute Commissary Shopping Spree (limit of \$500); second place wins a 2-minute spree (limit of \$300); third place wins a 1-minute spree (limit of \$200). Additional rules apply to the shopping sprees and will be provided to the winners. The hunt is **tentatively** scheduled for Wednesday, December 6, 7 a.m. at the South Post Commissary.

**OTHER INFO** - Open to all service members and their Families who are assigned to Fort Bragg, including all tenant units. Directorate of Family & Morale, Welfare, & Recreation employees and their Family members, as well as any individual not eligible to utilize the Commissary may participate but are not eligible to win prizes.
