### **Army Sharp Learning Strategy**

The Army SHARP Learning Strategy was approved on June 22, 2018. It outlines the comprehensive approach for building Army-wide prevention and response capability, and contributing to readiness through SHARP leader development, education, and training. The strategy applies to the Total army, and serves as a reference for SHARP Professionals, all leaders and the trainers and instructors delivering SHARP learning content and products Army-wide.

The U.S. Army Sharp Academy at Fort Leavenworth, KS, prepared this strategy in close coordinated with the Army SHARP Office. The document nests with and supports the execution of the SHARP Campaign Plan. Further, it aligns with other complementary efforts including the Army Framework for character Development, The Army Learning strategy, and the Army Leader development Strategy. Ref. ### **About RAINN**

The Department of Defense (DoD) has contracted with The Rape, Abuse & Incest National Network (RAINN) to provide confidential and anonymous services for the DoD community.

RAINN is the nation's largest anti-sexual violence organization and was rated by *Worth* magazine as one of "America's 100 Best Charities." RAINN created and operates the National Sexual Assault Hotline (800.656.HOPE) in partnership with over 1,000 local sexual assault service providers nationwide. RAINN also runs the award-winning National Sexual Assault Online Hotline (online.rainn.org) available in English and Spanish (rainn.org/es). Together, the hotlines have helped more than 2 million people since 1994.

RAINN also publicizes the hotlines' free and confidential services; educates the public about sexual violence; and leads national efforts to prevent sexual violence, improve services to victims and ensure that rapists are brought to justice.

Department of Defense (DoD) Safe Helpline services are provided by RAINN through a contract with the DoD's Sexual Assault Prevention and Response Office (SAPRO) — however, your information will remain confidential. RAINN will not share your name or any other personally identifying information with SAPRO or your chain of command, unless required by law. RAINN has adapted the award winning National Sexual Assault Online Hotline to provide specialized live help online at SafeHelpline.org to members of the DoD community who have been sexually assaulted. All Safe Helpline staff members have been trained to answer questions relating to military-specific topics such as Restricted and Unrestricted Reporting options and how to contact relevant military resources, such as the installation or base Sexual Assault Response Coordi-

Reprisal

Reprisal: Taking or threatening to take unfavorable personnel action, withholding or threatening to withhold a favorable personnel action, or any other act of retaliation, against a military member for making or preparing a protected communication is prohibited. (AR 600-20. glossary) Acts of retaliation or intimidation of any sort will not be tolerated.

# Threats or acts of reprisal are forbidden by Army and DoD policy and are punishable under Uniform Code of Military Justice

### Crime Victim's Bill of Rights

- Be treated with fairness, dignity and respect for one's privacy.
- Be reasonably protected from the accused.
- Be notified of court proceedings.
- Be present at public court proceedings
- Be present at public court proceedings unless the court determines otherwise for good cause.
- Confer with the attorney for the government in the case.
- Restitution, if appropriate.
- Receive information regarding conviction, sentencing, imprisonment and release of the offender from custody.

### **Definition of Consent**

The term 'consent' means a freely given agreement to the conduct at issue by a competent person.

- An expression of lack of consent through words or conduct means there is no consent.
- A current or previous dating or social or sexual relationship by itself or the manner of dress of the person involved with the accused in the conduct at issue shall not constitute consent.

- Avoid using language that objectifies or degrades women and men
- Speak out if you hear someone else making an offensive joke or trivializing rape.
- If a friend says they have been raped, take your friend seriously and be supportive
- Think critically about the media's messages about women, men, relationships, and violence
- Be respectful of others' physical space even in casual situations
- Let survivors know that it is not their fault
- Hold abusers accountable for their actions: do not let them make excuses like blaming the victim, alcohol, or drugs for their behavior.
- Always communicate with sexual partners and do not assume consent
- Do not let stereotypes shape your actions.
