This also discourages activity and general fitness.	the Fort Bragg leadership identified the need for walkable communities in the development of the Fort Bragg Integrated Strategic Sustainability Plan in May 2003. As such, the DPW Master Planning Division has incorporated walkable community concepts in the preparation of the Area Development Plans across Fort Bragg. As areas are developed, every effort is made to improve the sidewalk network to facilitate foot traffic across the installation. Where feasible, sidewalks are also constructed as part of road improvement projects. The XVIIIth Airborne Corps standard (as per CORPs PAM 600-2) states: Retreat. The Retreat ceremony is another military tradition. It symbolizes the respect we as citizens and Soldiers give to our flag and our country. This meaningful tradition is celebrated in two distinct parts: the bugle call "Retreat" followed by the bugle call "To the Colors" or, if a band is available, the National Anthem. (1) When outside in uniform (not in formation) and you hear "Retreat," you should face toward the Colors, if visible. If the Colors are not visible, face towards the US Flag on the flagpole, and assume the position of "Attention." During retreat ceremonies, all vehicles in the area will stop. Military occupants will dismount the vehicle and render the proper courtesy. When required, the senior Soldier should bring the formation to attention and salute. (2) If you are in civilian attire and hear "To the Colors" or the National Anthem, you are expected to place your right hand over your heart and remove all headgear. It is also authorized for active duty and retired personnel to salute while in civilian attire. (3) During an inside ceremony (not in formation), military personnel will stand at "Attention" and will not "Present Arms" unless the ceremony is specified to be an outdoor ceremony conducted indoors. (4) If in a POV, in uniform or not, you will safely pull to the side of the road, all military passengers will exit the vehicle and take the proper actions stated above Vehicles are not expected to stop on major roadways (All American, Reilly, Butner, etc) due to safety concerns	Complete

Drop-off requires staff to review each medication order for completeness, accuracy and stock availability prior to the patient driving off. This would be cumbersome and time consuming in the drive thru area. The number of prescriptions dropped by any single patient varies greatly (i.e. one patient could be dropping off one prescription for a single patient or twenty prescriptions for multiple patients). The time to accomplish this task varies proportionality with the degree of difficulty. Refill pick up itself does not vary nearly as much and allows a fairly continuous and smooth process.
