SUBJECT: Fort Bragg Sports Program, 2021 Summer Basketball Tournament

- 1. Reference. Army Regulation 215-1, 24 September 2010, Military Morale, Welfare, and Recreation Programs and Nonappropriated Fund Instrumentalities.
- 2. Purpose. To provide policies and procedures to assist installation sports directors with the implementation of the 2021 Summer Basketball Tournament.
- 3. General.
- a. Fort Bragg 2021 Summer Basketball Tournament will be held August 12 -14, 2021.
 - b. Player eligibility.
- (1) All active duty military personnel, DoD civilians, national guard and reserve personnel assigned to official units, detachments and activities on Fort Bragg 18 and older are eligible to participate.
- (2) If a protest results from the alleged use of an illegal player during the tournament, and the protest is upheld, the offending team will forfeit the game in question. If the protest is during the championship round the team will forfeit all games for tournament play.
- (3) For all games, team members must have their Military/ Department of Defense identification (ID) card. Inspection of ID cards will be made prior to each team's first game and may be required at any time during the tournament. Players who fail to present their military ID card, before the start of a scheduled game or start of play, will not be allowed to participate.

d. To enter, teams must submit a roster to the sports office. The Sports Office is located at 3725 Reilly Road, Building 190, (located behind the plane display at Pope's Reilly Road entrance) Pope Army Airfield, NC 28308. Tournament is limited to 15 players and 1 Coach.

e. Protests.

- (1) Player eligibility will be the only grounds for protests. Regarding misapplication of rules, teams will be required to follow the correctable error procedure as outlined in the rulebook.
- (2) Eligibility protests must be brought to the attention of game officials and/or the site supervisor prior to the conclusion of the game in question and be annotated in the official scorebook. At that time, game officials and/or the site supervisor will gather the pertinent data from the player or players in question (check ID card and confirm name, rank, and SSN).
 - f. A team not present at the scheduled game time will forfeit the game.
 - g. Team rosters.
- (1) In order to participate, personnel must be identified on a properly completed roster signed by the unit's commander. Noncompliance will result in forfeiture of the game or non-participation.
- (2) Team rosters must be submitted by August 10th, 2021. Rosters must include the following: name, rank, unit, SSN (last four), and team POC to include duty phone number and e-mail address.
- (3) Team rosters are limited to 15 players. Once the tournament begins, rosters cannot be amended.
- 4. Rules. Current National Federation of State High School Associations rules and interpretations and local by-laws and amendments will govern all play. Here is the link to the rules; https://www.nfhs.org/activities-sports/basketball/

1. Additional by-laws are as follows:

- a. Game Length: 2-18 minute halves during all games except championship game, which is 2-20 minute halves. Clock will continuously run and will stop for normal violations at 1-min remaining in the first half, and 2-minutes remaining in the 2^{nd} half. During championship game, to include if game, the clock will stop at the same prescribed times. Championship game only will be 2- 20 minute halves.
- b. The half-time rest period will be up to 4 minutes in duration. Overtime periods will be 2-minutes in duration. After the third overtime period, the game will become a sudden death game in which first team scores, 1 pt., 2pt. or 3pt. goal successful attempt, wins the contest.
- c. Any player or coach who is ejected from a tournament game, will be suspended for one game and thus be ineligible to participate in the next game which his/her team plays. Any player or coach who intentionally makes physical contact with an official, scorekeeper or Sports Office representative, will be suspended for the tournament's duration.
- d. Each team will be awarded 2 timeouts, 1 30 sec. and 1-60 sec., per half. Timeouts will not carry over. In overtime, only 1 timeout, per overtime period is allowed, 1 -60 sec. timeout. During overtime no timeouts from previous periods will be allowed.
- 5. Awards. Sports Section will provide team awards for first, second, and third place. Individual awards, in the form of T-Shirts, will be presented to the champion and runner up teams.
